**Dear Director Clements:** 

The Committee on the Judiciary is conducting oversight of the programs and operations of the Community Oriented Policing Services (COPS) within the Department of Justice (DOJ). For fiscal year 2024, COPS has requested a substantial budget decrease. The Committee must examine COPS's current operations and processes to determine if existing resources and funds are being used in the most efficient manner.

During the last fiscal year, COPS received nearly \$670 million in taxpayer funds and employed 100 full-time and part-time employees.<sup>2</sup> COPS's FY 2024 request would decrease the Office's budget to \$651 million.<sup>3</sup> The FY 2024 budget request includes a cut of nearly \$12 million in program funding.4

As part of the Committee's constitutional oversight responsibilities and especially in light of the COPS's substantial budget request, the Committee must understand all current and proposed COPS-funded grants to (1) determine if the taxpayer-funded grants meet congressional intent; (2) ensure the grants are being properly executed, funded, and monitored; and (3) to measure the effect of COPS grants on the desired communities. The Committee's oversight will inform possible legislative reforms to bring COPS back in line with its statutory authorization and mission.<sup>5</sup>

Furthermore, the FY 2024 budget request outlines requests for more personnel, bringing the total positions at OVW to 165 employees.<sup>4</sup>
